

# SHIFT SUPPLIES LTD. CLEANLINE LIMITED 7 YEAR WARRANTY

SHIFT SUPPLIES LTD ("Shift") CLEANLINE FENCE WARRANTY IS AS FOLLOWS.



SHIFT WARRANTS TO THE ORIGINAL CONSUMER PURCHASER THAT IF THEIR CLEANLINE FENCE PROVES TO BE DEFECTIVE IN MATERIALS OR WORKMANSHIP DURING NORMAL AND PROPER USE OF THE PRODUCT, WITHIN SEVEN (7) YEARS FROM THE DATE OF ORIGINAL SALE, OR SUFFERS SIGNIFICANT FADING, BREAKDOWN OR DEGRADATION DUE TO EXPOSURE TO NATURAL ULTRAVIOLET RAYS WITHIN THE SAME SEVEN (7) YEARS PERIOD, SHIFT WILL, AT ITS SOLE OPTION EITHER 1) REPAIR OR REPLACE THE DEFECTIVE FENCING PRODUCT WITHOUT CHARGE TO THE ORIGINAL CONSUMER PURCHASER, OR 2) ISSUE A CREDIT EQUAL TO THE COST OF THE CLEANLINE FENCE MATERIAL ONLY. THE CREDIT SHALL BE ISSUED TO THE RETAILER, AS A PERCENTAGE OF THE REPLACEMENT COST OF THE NEW CLEANLINE FENCE OF THE SAME OR COMPARABLE QUALITY. THE CREDIT WILL BE GOOD ONLY TOWARD THE PURCHASE OF SHIFT'S FENCE PRODUCTS. THERE WILL BE NO CASH PAYMENT.

**THIS WARRANTY ONLY APPLIES TO CLEANLINE FENCE INSTALLED IN ACCORDANCE WITH SHIFT SUPPLIES' INSTALLATION GUIDELINES AND SPECIFICATIONS.** The fence must be maintained in accordance with Shift Supplies' maintenance recommendation and such maintenance continue throughout the warranty period. - This warranty is limited to the remedies of repair or replacement of the defective fencing product, which shall compromise the exclusive remedy available under this warranty. all other remedies or actions that might otherwise be available are hereby waived and relinquished by the consumer purchaser.
- This warranty does not cover the installation of the Cleanline fence or any issues stemming from installation.
- Prorated material value to be covered at a rate of less one seventh (1/7) per annum from the date the consumer purchaser purchased the fence.
- This warranty does not cover deterioration resulting from normal wear and tear or any damages caused by site conditions and improper installation beyond its control, accidents, misuse, abuse, neglect, tobacco products, solvent, epoxies, glues, paints, chemicals or cleaning agents, fire, floods, vandalism, acts of god.
- This warranty does not cover any damage resulting from impact of foreign objects or repair or attempted repair by anyone other than by a Shift representative, or its authorized agents, retailers or subcontractors.
- Shift hereby disclaims any and all warranties, express or implied, including warranties of merchantability and fitness for a particular purpose and disclaims liability for incidental or consequential damages.
- Shift specifically excludes and will not pay consequential or incidental damages under this warranty. This includes any damages arising out of or in connection with the use of the Cleanline fence, including, but not limited to damages arising out of or in connection with the use, including, but not limited to damages for economic loss, expense, personal injury etc.
- This warranty is non-transferable. This warranty is only extended to the original consumer purchaser.
- All warranty claims must be presented in a timely fashion to shift in writing and as soon as an issue with Cleanline fence products become evident.
